CRP Terms and Conditions:

The term new business* means a referral resulting in billable services to a new client or a former client with whom we have not done business with for at least one (1) year.

Referral Credits:

Referral credits are based on the total amount billed for a new client's first full month as follows:

<i>First Month's Billing</i>	<i>Credit Amount</i>
= \$ 1,000.00	\$250
= \$ 5,000.00	\$500
= \$ 7,500.00	\$750
= \$ 10,000.00	\$1000
> \$ 20,000.00	\$ 2,500

Awarding of Incentives:

- Referral credits are based on the first full month billing to the referred client and will be awarded within 2 weeks of the end of the full month billing cycle.
